# Jackson County Public Library Board of Trustees Special Meeting Minutes December 14, 2020 Ravenswood, WV 26164

# 1.) Call to Order:

Suzy McGinley called the meeting to order at 6:15pm. Present: Suzy McGinley, Denise Toler, Grace Arthur, Savanna Whited, Katrena Ramsey, John Faria (Library Director), Angela Howard (Ravenswood Branch Manager).

### 2.) Review of Minutes:

**A.)** November Minutes – Board has reviewed the minutes in Dropbox. Denise Toler moved to pass the minutes. Katrena Ramsey seconded the motion. Motion passed.

# 3.) Public Comment:

### A.) Executive Session

- Grace Arthur moved to give the 2 employees that did not receive the 2019 supplemental pay, receive in addition to the 2020 supplemental pay. Katrena Ramsey seconded the motion. Motion passed
- Grace Arthur moved to add to the Personnel Policy, on page 3 under item 4. Probationary Period, *All* entry level positions will be hired in at a probationary pay rate of \$9.10/ hour from the start date. After a successful completion of the probationary period the employee will receive a merit pay increase to \$10.47/hour. Denise Toler 2<sup>nd</sup> the motion. Motion passed.
- -Katrena Ramsey moved that the 2 employees at the Ripley branch that have surpassed the 3-month probationary period receive back pay, with interest, to the full merit pay amount from the date of the November Board meeting date (11/19/2020). Denise Toler seconded the motion. Motion passed.
